**1. Meeting called to order**

a. Comparative Review of 2009 Constitution Order

The Secretariat verbally confirmed that a review was conducted by the Constitutional Review Secretariat to confirm that the content of the Cayman Islands Constitution Order 2009 was the same as that published in the draft document approved in the referendum.

b. Website

The Commission tasked the Secretariat with making amendments to the FAQs before it approves them for the website and informed the Secretariat that the member bios will be submitted in the near future.

c. Constitution Week

The Commission requested that a schedule of events for Constitution Week be sent to all members.

d. Logo Competition
