Governor and other key stakeholders in order to create a forum for communication and open dialogue on matters of the Constitution and to determine the best course of action for addressing these issues...

b. Meeting with the Electoral Boundaries Commission

The Chairman had a short meeting with the Chairman of the EBC prior to the last ii. Commission meeting on April 20, 2010 and relayed to his fellow Commission members, the remit of the current EBC.

- iv. The Commission decided it was not necessary to attend a formal meeting with the EBC but will make every effort to attend a public meeting.
