1. Call to order

The meeting was called to order at 10:06am. The Chairman thanked all for attending.

2. Confirmation of Previous Minutes

The Chairman was provided with minutes of the meetings held on 1 August 2018 and 17 October 2018 to review for finalisation.

a. Overview

b. Proposed Constitutional Amendments

The Chairman provided an update on the progress of the proposed constitutional amendments to-date. Members were advised that the Hansard report from the Legislative Assembly debate on this issue from 6 December 2019 was available electronically, and the same would be circulated to members.

A draft explanatory note for the recent proposed constitutional amendments was discussed. Members agreed for the Chairman to review the document and comment in the first instance, and then circulate it for other members to provide any further contributions. The Commission's comments will then be provided to His Excellency the Governor, the Hon. Premier and the Hon. Leader of the Opposition.
